The National Pulse can reveal the Black Lives Matter website – the organization spearheading nationwide <u>"defund the police"</u> campaigns – is partnered with ActBlue, a Democrat fundraising platform that is the top donor to Democratic presidential candidate Joe Biden, responsible for raising nearly 99.64 percent of the Biden for President effort.



And Biden for President, the campaign's official committee, is the main source of revenue for the former veep's presidential efforts, surpassing all other fundraising organizations by over \$100 million.

ActBlue contributions comprise 99.64 percent of all funds raised for the "Biden for President" entity and the total is nearly 773 times greater than the group with the second-highest donation sum.
