We do not handle small-scale cases or individual problems unless they are indicative of a large-scale problem. We also do not handle EEO issues (those dealing with non-whistleblower related discrimination, or discrimination based on age, gender, religion or race) unless they are brought in conjunction with a whistleblower case. However, we do accept Qui Tam cases.
