

Starr's appeal of the OHA's initial agency decision under the Department of Energy's (DOE) Contractor Employee Protection Program, 10 C.F.R. Part 708. April 5, 2021

Proceedings under 10 C.F.R. Part 708 offer employees of DOE contractors a mechanism for resolution of whistleblower complaints by providing for independent fact-finding and a hearing before an OHA Hearing Officer, followed by an opportunity for review by the Secretary of Energy or her designee.

Under 10 C.F.R. Part 708 ("the whistleblower regulations"), DOE contractor employees who believe that their employers retaliated against them for making a protected disclosure may file a complaint with the Head of Field Element or with the DOE Employee Concerns Director (hereafter collectively "Field Elements").

On August 8, 2005, President Bush signed the Energy Policy Act of 2005 . The Act includes three amendments to the Energy Reorganization Act relating to whistleblower cases. The first amendment is contained in Section 627. It prohibits the Department of Energy from reimbursing a contractor or subcontractor for legal fees incurred subsequent to ...
