## How Alpha Team 8 overthrew a modern Coup D’Etat attempt against the U.S. Government

The story sounds like something from a comic book. This is a true story, though. It all really happened.

It was then a simple matter to compile a report on those parties and submit copies of that report to every regulatory, law enforcement and transition team entity who had an interest in the case. ## Why was it so important to do this?

Alpha Team was tasked with ending an attempted take-over of the federal treasury, where the money of every taxpayer in America is kept. The "bad guys" were stealing over a trillion dollars of U.S. citizen's money in order to place that cash in the personal bank accounts of power-mad, narcissist Silicon Valley billionaires.

This is not the first time this kind of Coup was attempted. South American governments are well known for their predilection to engage in such take-over schemes.

America had a previous similar coup attempt in 1933. The history books tell the story of the renown U.S. Marine Major Smedley Butler. It was J.P. Morgan and Steel industry magnates that attempted the Coup in FDR's time. This time around, the plotters were Silicon Valley billionaires.

## Who are these Alpha Team 8 people?

They are a task-force comprised of citizen-journalists, programmers, anti-Silicon Valley billionaires (probably not [Peter Thiel](#), though, but that can neither be confirmed nor denied), Congressional investigators, current and former FBI agents and a host of other unique characters. They were organized by a Senator, a technologist and a journalist but the effort soon took on a life of its own.

They created pre-formatted Wordpress, Wix and Weebly online newspaper systems and gave them away to thousands of writers, reporters, bloggers and authors with free server hosting for years in advance. They inspired famous reporters to leave their main-stream newspapers and start their own global “newspapers” online. They taught them how to do it and gave them the infrastructure to do it. In many



cases, the reporters were only contacted by a single person who offered to help them gain their independence. Alpha Team rarely stated that they were a group and they never told a reporter or “New News” publisher what to write. They simply picked the right kinds of people to support and they chose them by their previous history of not operating as shells and or mainstream media sheep.

The entire goal of Alpha Team 8 was “*the interdiction, arrest and entirely legal termination of corrupt persons and cartels..*”. They were a mix of Democrats, Republicans, Green Party and others who were NOT driven by party politics by, rather, by disgust at the depths to which the public policy process had descended. Seth Rich, Peter Thiel and Edward Snowden may be such persons.

They are well-armed with political humor, ironic metaphor, analogy, epic transparency, The Constitution, technology and a decade-old system designed to have every form of preparation ready for every opportunity and unexpected incident. Some of them are actual law enforcement and intelligence agents with actual concealed carry permits. They are deadly serious, highly skilled and brilliant.

They are defined by their results. As of today, you can see the results of the global news network they helped create in such homages to the new system as <http://wearethenewmedia.com>. This is one of many sites that celebrate the biggest change in public information in world history. There are now more independent non-campaign financier controlled news outlets reaching more members of the public, around the world, than ever before in history.

You can see hundreds of their peer-to-peer law enforcement centers online. One such example is <http://globalscoop.net>

You can see their handi-work as co-sponsors of the U.S. JOBS ACT “crowd-funding” support law modification to SEC regulations in order to cut the Silicon Valley VC’s out of the start-up monopoly they had created in Silicon Valley.

You can see their results in the [Silicon Valley No Poaching Class Action Lawsuit](#), which they helped produce, because Eric Schmidt and Steve Jobs had created a Cartel to attempt to harm over 60,000 engineers via secret black-lists. Silicon Valley lost that law suit.



They contacted White House Press secretary Robert Gibbs and his staff and informed him that the Coup was exposed and Gibbs was under investigation. Gibbs suddenly quit the White House in a recession, with not better job offer. It was obvious that he quit out of fear. They did the same thing to Eric Holder, The U.S. Attorney General. He quit too. They did the same thing to Erick Strickland, Head of the NHTSA, who was covering up campaign finance conduits: Tesla and GM safety issues in order to protect the White House.

Law Firm Covington and Burling had put Eric Holder and Steven Chu in their federal positions (on behalf of The Cartel) and had helped try to recruit some of Alpha Team into their scheme. Alpha team members told them to “get screwed” and reported them to the FBI.

They helped set-up a corruption lawsuit against Steven Chu, Secretary of Energy, Lachlan Seward, Energy Department Funding Head and the U.S. Department of Energy itself, which was being used as an illegal slush-fund to pay off Obama’s and Clinton’s campaign financiers Chu, Seward and over 40 other corrupt Department of Energy were fired, placed under investigation and exposed as political criminals.

Solyndra, Inc, one of the Cartel’s kick-back company was FBI-raided, bankrupted, and ceased operations after some Alpha Team members whistle-blew on the Coup attempt.



The Team created multiple public interest lawsuits, on behalf of the public, aimed at anti-corruption efforts, they were filed in state and federal courts and made public by order. They sought to expose, disgrace and terminate the efforts of those who were criminally involved in such illicit actions. The Court System provides a way to permanently archive documentation about these crimes so that the public can watch for any similar future attempts. Alpha Team has created historical “firsts” in legal standings, known as *Precedents*.

The Alpha’s created the detailed public documentation of the kick-back and payola methods employed by the corrupt public policy staff, in such a manner that millions of voters now know how their illegal

methods work and how to spot those attempts in future scams.

The geeky part of Alpha Team 8 created novel new transparency technologies and the open-source distribution of those technologies, globally, on behalf of the public, for free, non-commercial use. These resources were used for the creation of a series of collaborative public/private task-force efforts including the launch of numerous new digital news and information resources, the development and five year+ operation of a multi-hundred server Internet testing system to investigate search engine targeting of victims by the corrupt operators at Google, Inc., Facebook and Twitter. This internet sting operation fully documented the rigging of the internet by these three.

In the course of their actions, the Team received the first federal court ruling in U.S. history in which the federal courts confirmed that members of the public were targeted by corrupt federal employees.

Alpha Team's efforts resulted in the savings of over \$800 million dollars, and up to \$2 trillion, for the U.S. Treasury and the American taxpayers because they curtailed political corruption which was stealing that money. The Team were the providers of information resources to the United States Congress in support of active investigations in Congress, The European Union and Federal law enforcement agencies.

## **The attacks against Alpha Team**

Alpha Team 8 has paid the price of tangling with these crooks. The cost has been dear. A report prepared for the FBI states the following”

*“In 2007 the suspect group formed an illicit quid-pro-quo program primarily based in Chicago, Illinois; Palo Alto, California and the San Francisco Bay Area; Washington, DC and New York City, New York. The multi-state operation of this RICO-class activity brings this matter under the purview of the Federal Bureau of Investigation and related federal law enforcement agencies.*

*The attempt was made to embezzle trillions of dollars from the TARP, DOE ATVM/LGP, DOT, EPA and DoD budgets by the suspect group, using the 2007/2008 confusion of the economic crash as cover. Indeed, history has proven that a portion of the scam was successful. The FBI raid of Solyndra and the House Ethics Reports and investigations subsequently led to key interdictions in the crimes. Final interdiction has yet to be completed.*

*In order to operate the cover-ups and intimidation program which sought to keep these crimes from being overtly exposed, Bloggers John Herrman (working for the Gawker Cartel's Gizmodo and now with the New York Times) and Adrian Covert (Working for the Gawker Cartel's Gizmodo and now with CNN Money and CNN) received various forms of compensation in exchange for operating retribution, reprisal and vendetta media production against witnesses, informants and opposition journalists.*

*In the course of these crimes a number of deaths occurred which are directly attributable to those involved in these crimes. The complete suspect group includes public officials, Silicon Valley campaign financiers, complicit publishers including Gawker Media, Media Matters, Think Progress, New America Foundation and In-Q-Tel. All of these parties exchanged goods, compensation, intangible assets, stock value, and operational directives which fully, and extensively subjects them to the full force of the law in complete and superlative violation of the set of laws known as “THE RICO STATUTES”.*

The following reports, provide indictment validation for the portion of the case dealing with the ongoing surveillance results of bloggers John Herrman and Adrian Covert and the parties they have communicated with via text messages, voice-mail boxes, email, in-taxi comm pick-ups, restaurant and public space security systems, SR spoof, GPS and cell tower triangulation daily sequences, UBER/LYFT reports, Android/Apple sweeps....”

These two bloggers were part of the first wave of media attacks that were focused on character assassinations, economic annihilation, witness intimidation, political retribution, White ordered vendettas and the killing of every resource of those who opposed, reported or conflicted with the Coup.

Nick Denton and Gawker Media were operated by the DNC and Silicon Valley bosses. Gawker did the “take-downs” of politicians and witnesses until Hulk Hogan and Alpha Team started taking them down.

CNNMoney has tapped tech reporter Adrian Covert to cover Apple devices and other gadgets for the technology section of the business website.

Covert is currently an associate editor at [Gizmodo.com](#), where he started out as an editorial assistant in 2007. (Although his [LinkedIn profile](#) says he is a "space assassin," which is actually an important function of tech writing that most recruiters overlook.) He'll be working the gadgets beat for CNNMoney starting December 3.



Said CNNMoney managing editor Lex Haris in an announcement sent this morning:

Adrian comes to us from Gizmodo, and brings a deep knowledge of tech trends, news sense, and sharp writing style (the headline "Hey Netflix, get your s\*\*\* together" was one of our favorites). And we all loved a sly line on his resume noting that he was Time Person of the Year in 2006 — back when YOU were too.

Adrian will be on the gadget beat, focusing on news and reviews about the steady stream of devices churned out by Apple and all of its rivals. It's an important piece of our tech coverage that Stacy's been pushing for, bolstering the already important pillars that we cover so well: Social media, start-ups, security, mobile, as well as the deep Big Tech expertise from Fortune and consumer offerings from [CNN.com](#). It's no wonder the section has had such explosive growth — up 98% in the past two years.

Actual murders seem to have even been committed by the suspects. From 2007 to 2016, over 220 individuals who were threats to the Coup suddenly died in strange and suspicious ways after being in perfect health the day prior. Each one had a previous fall-out with the key beneficiaries of the Coup including Google's John Doerr, Jared Cohen, Larry Page and Eric Schmidt; Tesla's Elon Musk, Facebook's Sheryl Sandberg and Mark Zuckerberg and Twitter's Jack Dorsey. A document, widely available on the internet, called "[The Cleantech Death-List](#)" documents the growing list of suspiciously dead folks who were all enemies of the above and their bought and paid for politicians.

Now, in a number of notorious trials and email leaks, including the Hulk Hogan lawsuit and the DNC and Panama Papers leaks, the public has gotten to see the depths to which public officials are willing to stoop to cheat rather than compete in the open market.

Department of Energy employees and State of California employees engaged in the following documented attacks against applicants who were competing with their billionaire backers personal stock holdings. The documented attacks that Alpha Team 8 suffered included:

- Social Security, SSI, SDI, Disability and other earned benefits were stone-walled. Applications were "lost". Files in the application process "disappeared". Lois Lerner hard drive "incidents" took place.
- State and federal employees played an endless game of Catch-22 by arbitrarily determining that deadlines had passed that they, the government officials, had stonewalled and obfuscated applications for, in order to force these deadlines that they set, to appear to be missed.
- Some applicants found themselves strangely poisoned, not unlike the Alexander Litvenko case. Heavy metals and toxic materials were found right after their work with the Department of Energy weapons and energy facilities. Many wonder if these "targets" were intentionally exposed to toxins in retribution for their testimony. The federal MSDS documents clearly show that a number of these people were exposed to deadly compounds and radiations without being provided with proper HazMat suits which DOE officials knew were required.
- Applicants employers were called, and faxed, and ordered to fire applicants from their places of employment, in the middle of the day, with no notice, as a retribution tactic.
- Applicants HR and employment records, on recruiting and hiring databases, were embedded with negative keywords in order to prevent them from gaining future employment.
- One Gary D. Conley and one Rajeev Motwani, both whistle-blowers in this matter, turned up dead under strange circumstances. They are not alone in a series of bizarre deaths related to the DOE.
- Disability and VA complaint hearings and benefits were frozen, delayed, denied or subjected to lost records and "missing hard drives" as in the Lois Lerner case.
- Paypal and other on-line payments for on-line sales were delayed, hidden, or re-directed in order to terminate income potential for applicants who competed with DOE interests and holdings.



- DNS redirection, website spoofing which sent applicants websites to dead ends and other Internet activity manipulations were conducted.
- Campaign finance dirty tricks contractors IN-Q-Tel, Think Progress, Media Matters, Gawker Media, Syd Blumenthal, etc., were hired by DOE Executives and their campaign financiers to attack applicants who competed with DOE executives stocks and personal assets. Alpha Team members sued In-Q-Tel and Gawker, forcing them to expose themselves in U.S. Court rooms.
- Covert DOE partner: Google, transferred large sums of cash to dirty tricks contractors and then manually locked the media portion of the attacks into the top lines of the top pages of all Google searches globally, for years, with hidden embedded codes in the links and web-pages which multiplied the attacks on applicants by many magnitudes.
- Honeytraps and moles were employed by the attackers. In this tactic, people who covertly worked for the attackers were employed to approach the “target” in order to spy on and misdirect the subject. Match.com and OKCupid had honeytrap moles placed on them to try to lure Alpha Team members into compromising situations. Micheal Arrington, of TechCrunch, was lured into such a honeytrap, as described by this [Vanity Fair article](#). This was the payback he suffered for exposed the AngelGate Collusion meetings.
- Mortgage and rental applications had red flags added to them in databases to prevent the targets from getting homes or apartments.
- McCarthy-Era "Black-lists" were created and employed against applicants who competed with DOE executives and their campaign financiers to prevent them from funding and future employment.
- Targets were very carefully placed in a position of not being able to get jobs, unemployment benefits, disability benefits or acquire any possible sources of income. The retribution tactics were audacious, overt..and quite illegal.

So, the next time you are asked to “Serve Your Country”, consider the implications if you do a good job. The price is heavy and offers little, or no, gratitude.

## How big were the crimes?

You will find a number of articles online referencing: ***“Afghanistan is the Saudi Arabia of Lithium”***, and ***“Trillions of dollars of Lithium in Afghanistan”*** and ***“Afghanistan Lithium War Profiteering”***.

These articles were promotions by the Silicon Valley Cartel in order to hype support for the Afghan War. The Obama Administration had promised the Silicon Valley Cartel exclusive access to those lithium mines for Google’s driverless cars, Elon Musk’s and Fisker’s Tesla’s and Solyndra’s solar tubes. All of these products self-ignited and cause cancer in their exposed and/or inflamed form. The lithium monopoly was payola for campaign financing.

That was not a very good scheme, it turns out. The Afghan war has cost America over seven trillion dollars in losses as of today. The lithium mines were a bust. Everybody lost on that bet.
