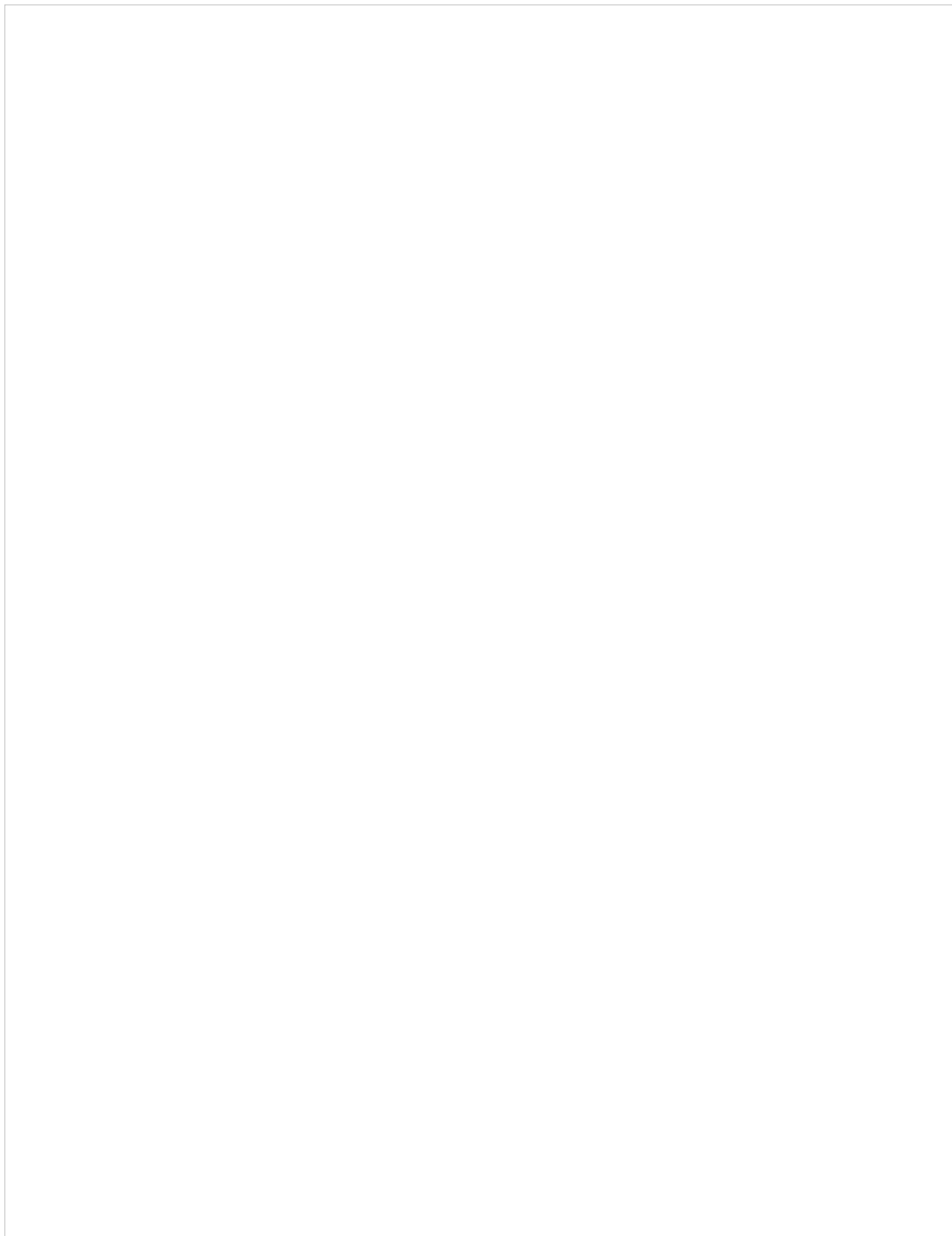

5.1 **Judge** or juror asking or taking a bribe - PC 93. Penal Code 93 PC is the California statute that makes it a crime for a judicial officer to ask for, or receive, any bribe. While PC 92 punishes **bribing** the judicial officer, this statute makes it a crime for the officer to accept the bribe. 5.2 Bribery by or of witnesses - PC 137 and 138

The crime of **bribing** or attempting to bribe a **judge** is punishable as a felony under Penal Code Section 92. The law also mandates felony punishment for any person who attempts to bribe someone authorized by law to decide court-related matters, including: • Jurors 1; • Court Commissioners • Referees; • Arbitrators; • Umpires.
