# NXIVM Victim Sues Clinton Global Initiative Member of Pedo Sex Cult Sara Bronfman

The deviant and dangerous NXIVM pedophile sex cult can be tied to multiple Hollywood elites who are currently on trial in the Eastern District of New York. Now it seems that one of the victims is filing lawsuit prior to the conclusion of the criminal trial, which is underway and all of the media is ignoring it.

Sara Bronfman, who now goes by Sara Bronfman-Igtet, is who was chosen to be a victim of the lawsuit brought in the Brooklyn Supreme Court as a class-action suit, NY two defendants who argue they were “ensnared.”

Both Isabella Martinez, Gabrielle Leal, and several others claim to be victims in “a fraudulent scheme nationwide” as part of the grotesque Keith Raniere led pedophile sex cult’s NXIVM front entity.

The NXIVM group that was supposed to give people life advice and a roadmap to success, ended up turning their world upside down.

“Part of the fraud committed to induce the purchase from ESP was the claim that the program was developed by the ‘one of the World’s Smartest Men’ – Keith Raniere,” the lawsuit argued.

The two students who filed the lawsuit say that Sara Bronfman proposed several outrageous claims about the “powers” of Keith Raniere, and they feel as if they were defrauded of their investment.

The language used to describe Raniere is highly suspicious, which Bronfman's wording seems as if this man was granted a unique set of supernatural capabilities.

Keep in mind the irony of it all.

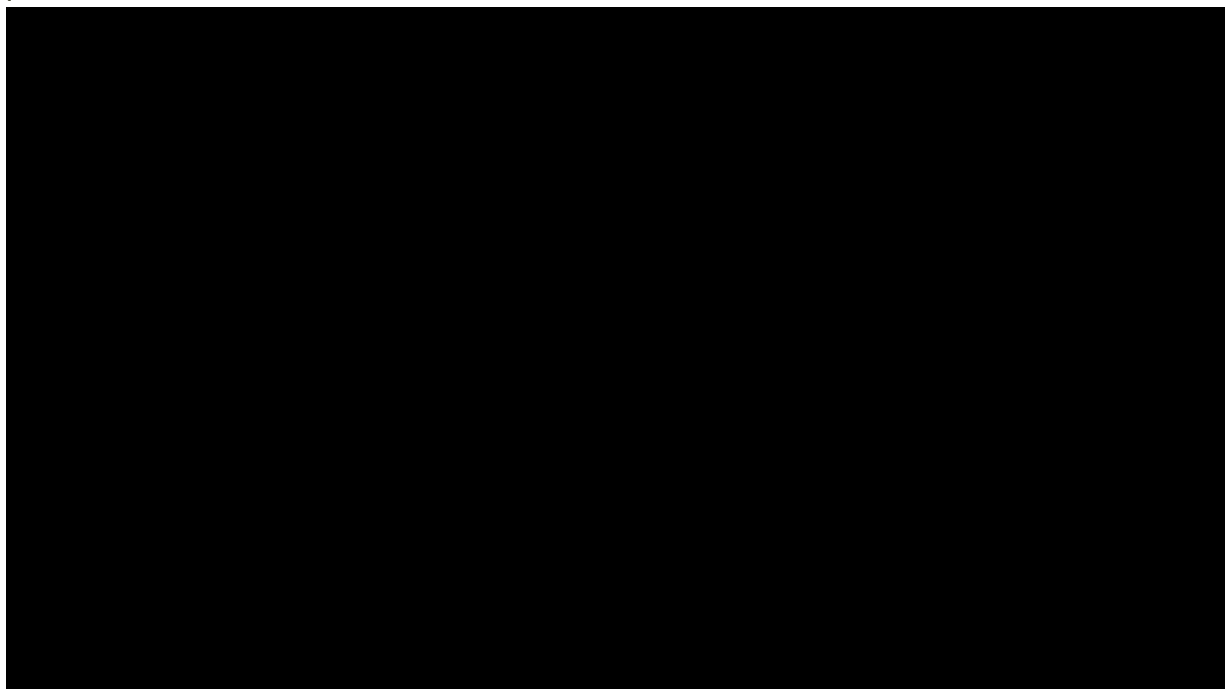
Maher tried to attack Trump supporters who follow the phenomenon of imageboard culture, in reference to "QAnon."


The reality is that the people of this country, not just the supporters of the 45th President of the United States of America, simply do not trust the media.

Haiti, infamously enough, is the place where the people have tried to protest the Clinton crimes, and the media still refused to cover it.

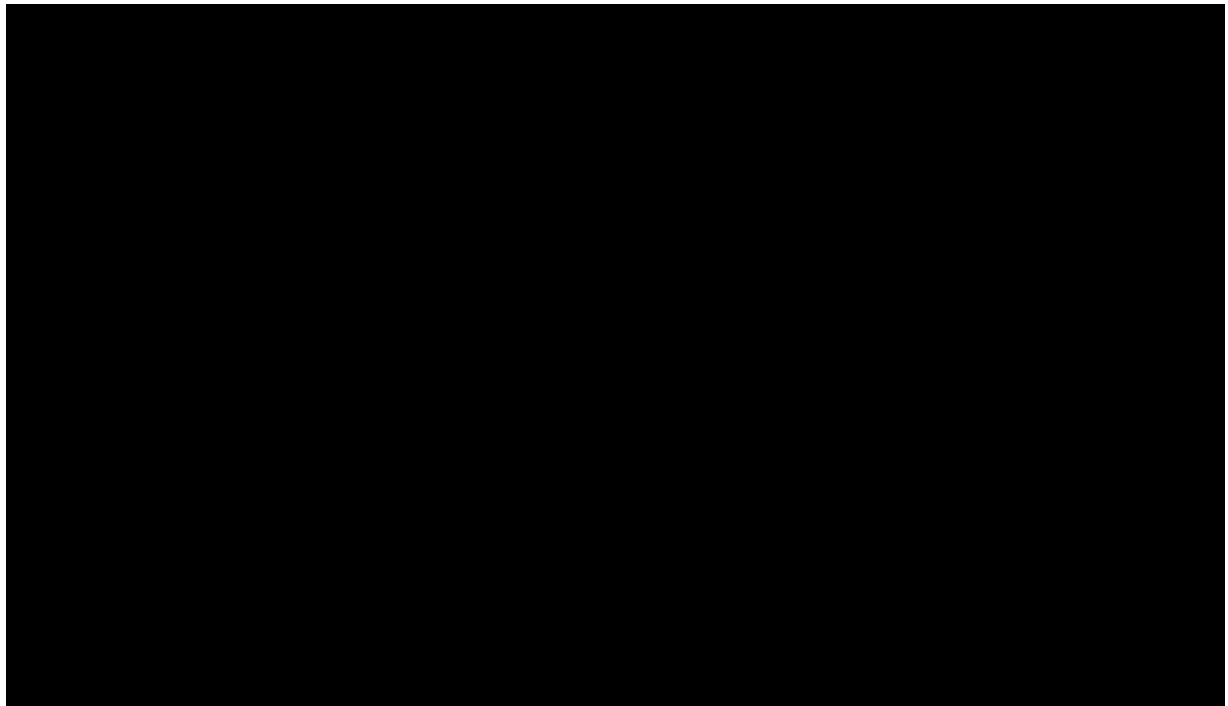
During the aftermath of the Haitian earthquake, in which the Clinton foundation robbed blind the island nation, the media didn't make a sound.

This is an ongoing reality and a problem that seems to only face those who criticize the Democratic Party's elite, especially their favorite *criminal Hillary Clinton*.



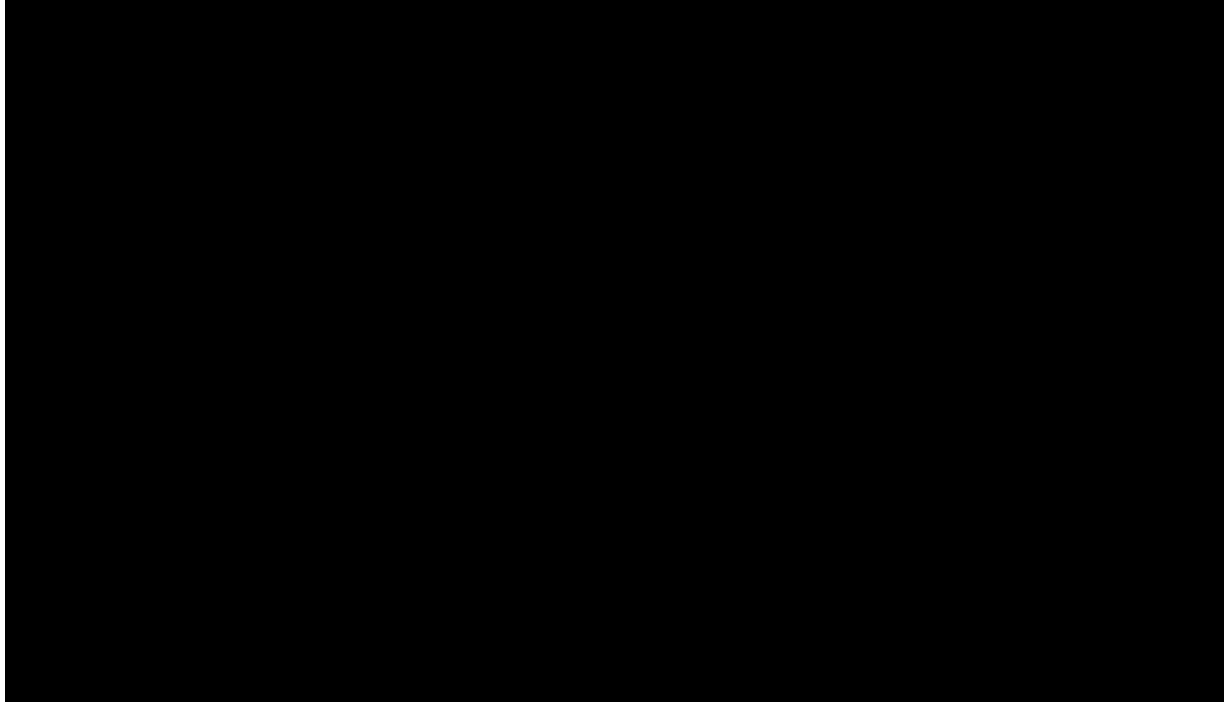

As per the lawsuit today, that's essentially what is being said of the front business used to avoid detection

Bronfman advertised that Raniere was "1) was one of the World's Smartest Men; 2) began talking in complete sentences by age one; 3) was an East Coast Judo Champion at age twelve; 4) tied the New York State record for the 100-yard dash in High School; and 5) had a very rare problem-solving ability that allowed him to create a curriculum to assist others with their business projects," according to the lawsuit.

The suit goes on to claim that the financier of the private island used to rape children, Clare Bronfman, "Failed to tell us the New York State Attorney General's Office sued Raniere for a prior business venture, which was deemed an illegal multilevel marketing business and for which he was fined," saying they were scammed out of cash.

"He is not one of the world's smartest men, he is not a judo champion," said the plaintiffs' lawyer, Omar Rosales. "It's all a lie, it's all a scam."

A scam it may be, but it was designed as a front organization to allow high ranking Democrats and powerful people to enjoy the rape and torture of many.

The U.S. State Attorney's Office in New York has said when they took Raniere, also known as the "Vanguard" by the cult, into their custody it was only after he was officially deported by Mexican authorities.

The problem is, after the date of the deportation?

Keith Raniere wasn't caught in the United States of America. He was found outside Puerto Vallarta, Mexico.

Clearly, someone, somewhere, was financing a bribe to the Mexican authorities or paid to shuttle Raniere back quickly after his deportation.

Both options seem plausible.

Raniere was living in that luxury villa, just a few months ago, thinking that the world was carefree and he would escape justice for his crimes against women and children.

he and the other Democratic elites have appeared before a series of judges, who will control their fate for their horrific crimes.

To make matters more interesting, the same 2007 article from [The New York Post](#) says that there were allegations of the cult's indoctrination:

At NXIVM – according to court papers, cult watchdogs and relatives of members – Raniere has defrauded devotees, shattered families and drove at least one person to suicide.

After four months attending NXIVM's expensive, "intensive" studies, Alaska resident Kristin Marie Snyder grew angry, depressed and irrational.

In winter 2003, she disappeared. Her family believes she drowned herself. Her body was not recovered. Snyder was last seen leaving an NXIVM course, and police released a note she left behind.

"I was brainwashed and my emotional center of the brain was killed/turned off," Snyder scrawled in a spiral notebook.

*That's one hell of a family business, Seagram's.*

*Allison Mack remains on trial for her role in the child and adult sex trafficking of NXIVM.*

While we await the conclusion, she has already appeared before United States Magistrate Judge Cheryl L. Pollak, already arraigned on vile and disgusting charges.

This should be punishable by death.

"Moreover, the student-victims' tuition was used to fund a criminal enterprise run by Defendant and her indicted co-conspirators," the new lawsuit says.

Both Martinez and Leal said they separately shelled out \$2,400 for a five-day intensive set of Nxivm classes in San Francisco in 2016 — but never would have done so had Bronfman-Igtet not lied to them.

That tiny sum should be nothing, since a pedophile financier like the 39-year-old Clare Bronfman can fork out a whopping [enough cash to buy an island, or even the \\$100 million dollar bond](#) she paid to free herself from jail, whereas she should never be allowed to see the light of day again.

Three other top-ranking members of the NXIVM pedophile sex cult are also on trial, in which many of the Democratic Party's bastion of elite politicians have been connected to, either through direct contributions to their political campaigns, or in the case of Senator Kirsten Gillibrand, her father has been directly on the payroll of the NXIVM pedophile sex cult, as reported by [Page Six, New York Post](#) , and even [Slate](#).

For those unaware, Nancy Salzman is a sitting member of the Clinton Global Initiative, which connects the Clinton family directly to a woman whose house is being raided by the Federal Bureau of Investigation, a huge story, and the mainstream media hasn't processed this yet. Whether that's intentional or not is yet to be determined, although alternative media and investigative journalists are always ahead of the curve since we're doing our own research.

She's also listed as a donor to Hillary Clinton's campaign for President in 2007, 2008, and 2016, according to the Federal Elections Commission, and if you input her name into the search results you'll see the data below.
