*“Among other things, the report revealed videos of [Paul Pelosi Jr.’s](#) 2017 trip to the country, which are currently being removed online.*

*“These accusations are similar to those against former Vice President Joe Biden and his son, who allegedly [earned \\$156 million from corruption schemes in Ukraine](#).*

*“President Trump shared an additional OAN report on Friday, in which Ukrainian officials testified on Democrat interference in the 2016 elections. He thanked One America News for “incredible reporting” and slammed mainstream media for not doing “the same.”*

You don’t have to go all the way to Ukraine to find allegations of corruption on ‘Nancy & Son’ when a decades old one exists at home—right in their own backyard.

Nancy Pelosi has been trucking with her son, Paul in shady development deals on home turf for years.

As [Canada Free Press](#) (CFP) noted in November of 2006:

*“Conflicts of interest mark the ambitious career of the House Speaker designate and her past will someday catch up with her, perhaps at a time most inconvenient for her Democrat colleagues.*

*“Breathtaking in sheer boldness, the conflicts are the stuff of movies, the kind with storylines in which the heroine lectures her defeated opponents about their ‘Culture of Corruption’, only to find herself at the center of her own ‘Culture of Corruption’.*

*“The plot of any realistic movie about the climb to power of Nancy Pelosi would showcase how powerful, greedy politicians push aside low-income families in projects that instead feather their own nests.*

*“The ostensible intent of the Federal Government’s 1988 Base Realignment and Closures act (BRAC) was to look after the little people first. All closed military bases would be privately developed for the benefit of neighboring support communities. At the end of the day, no one would be displaced or adversely impacted by the closings.*

*“Like many government schemes, it sounded good in theory, but the fairytale turned nightmare almost overnight.*

*“First came the Presidio and Pelosi’s role as an investor in a real estate investment entity called Presidio Partners.*

*“The Presidio Trust, a group of well-connected citizens, was charged with stewardship of the new national park.*

*“Then came Pelosi’s role in the 500-acre Hunters Point Shipyard.*

*“The Hunters Point Shipyard redevelopment measures have been called the most corrupt legislative initiatives to pass successfully through San Francisco.” ([San Francisco Bay View](#)).*

*“In order to speed up the process to have the lagging US Navy turn the property over to San Francisco, Pelosi used John Murtha, the powerful ranking Democrat on the House military appropriations subcommittee, who did her bidding to press to*

*have the Navy sign a binding agreement for the deal on a specific date.*

*“According to the San Francisco Chronicle, San Francisco Mayor Gavin Newsom met on March 31 in the Capitol offices of Pelosi.*

*“Pelosi is the aunt of Laurence Pelosi, Newsom’s cousin and one-time campaign treasurer.*

*“Also in attendance were Navy assistant Secretary Johnson, Senators Barbara Boxer and Dianne Feinstein, along with the influential Murtha.*

*“Laurence Pelosi is Senior Vice President of Lunar/BVHP, which has commercial development rights for the redevelopment of Hunters Point Shipyards.*

*“Most folk know that Nancy is the wife of a multimillionaire.*

*“Members of Gavin Newsom’s wine, restaurant, bar, resort and real estate partnerships since 1991 include Isolep Enterprises, Paul and Nancy Pelosi family personal investment company. ([SF Gate Feb. 23, 2003](#)).*

*“Nancy’s son Paul Pelosi Jr. was appointed to the Commission on the Environment by former San Francisco Mayor Willie Brown in 2003, and now serves as Vice President. ([SF Examiner](#))*

*San Francisco attorney Michael Yaki, a former member of the San Francisco Board of Supervisors is a past director in Rep. Nancy Pelosi’s office.*

*“Congresswoman Nancy Pelosi’s conflicts of interest in the Shipyard development have been reported to the U.S. attorney’s*

*office, the FBI and the Federal Elections Commission,” says a member “In the Know”.*

*“Pelosi is currently in the center of an open investigation by the FEC stemming from her documented use of charitable funds she received from the Tides Foundation and Center, a 501 (3) non-profit organization headquartered in San Francisco and controlled by Teresa Heinz Kerry.” (Sean Hannity)*

*“Interesting to note that the Tides Foundation and Center calls the Presidio home.”*

“In an email to the San Francisco Bay View, Laurence Pelosi verified that he was a Lennar senior executive in March of 2004 at the time San Francisco Mayor Gavin Newsom, his cousin for whom he had served as mayoral campaign treasurer, had signed the Hunters Point Shipyard Conveyance Agreement at the behest of Laurence’s Aunt Nancy Pelosi, speaker of the U.S. House of Representatives. *“After resigning from Lennar in May of 2004 – immediately before the shipyard conveyance legislation went before numerous City boards and commissions for approval – Laurence Pelosi joined the board of directors of the influential urban development think tank SPUR (San Francisco Planning and Urban Research) and went to work for Morgan Stanley.*

*“At a Dec. 14, 2003, hearing of the San Francisco Redevelopment Commission compounded by arrests, civil rights violations and invasions on the constitutional rights of the free press, the Redevelopment Agency approved a Disposition and*

*Development Agreement granting Lennar Corp. of Miami, a company that enjoyed annual sales of \$9 billion, exclusive development rights for the shipyard.*

*“San Francisco Mayor Gavin Newsom memorialized his violations of state and local ethics laws in January of 2005 by signing into law the Hunters Point Shipyard redevelopment measures he sponsored before the Board of Supervisors and accepting, in an official ceremony, the transfer of Shipyard Parcel A from the Secretary of the Navy in exchange for one dollar!*

*...The agreement came a few weeks after the Navy sent Newsom a letter saying it was having doubts about going ahead with a January 2004 symbolic agreement that had been announced, with potentially embarrassing fanfare, in Washington by Congresswoman Nancy Pelosi, former Mayor Willie Brown and Navy Secretary Gordon England. According to the Chronicle, Newsom met in the Capitol offices of “Aunt Nancy” on March 31, 2004.*

*“In attendance were Navy Assistant Secretary Hansford T. Johnson, Sens. Barbara Boxer and Dianne Feinstein and Rep. John Murtha, D-Penn., the ranking Democrat on the House Military Appropriations subcommittee, brought in by Pelosi to convince the Navy the time for delays had passed. Murtha made it clear he wanted a binding agreement signed “by Wednesday.”*

*“The Navy signed the accord despite new concerns the Radiological Affairs Support Office raised about the safety of the property for residential development due to the release of a massive investigation into the use of radioactive materials at the shipyard from 1939 to 2003. base at the Hunters Point Shipyard.*

*Anderson, a principle partner in Treasure Island Community Development, held a fundraiser in his Sacramento office in March to help Newsom retire his \$400,000 campaign debt."*

Unfortunately, while House Speaker Pelosi plays a leading role in the Trump Impeachment Inquiry, no one can hear the sound of scratching on the door coming from the skeletons in her corruption closet.

One doesn't have to dig too far into the past to unearth Nancy Pelosi's role in both the Presidio and Hunter's Point Shipyard development.

On October 22, 2018, [Pelosi sent out a press release](#) on securing \$60 million for Hunters Point:

*"Democratic Leader Nancy Pelosi issued this statement after securing \$60.4 million for Hunters Point re-testing and clean-up in the FY2019 Energy and Water, Legislative Branch, and Military Construction and Veterans Affairs omnibus spending bill:*

Meanwhile, how was it even possible that the hungry-for-power Democrats allowed Nancy Pelosi to be their House Speaker?
